HERE'S WHAT A DONATION TO THE COMMUNITY IMPACT FUND CAN DO:

- \$3** Per week provides:
- a **home visit** from a nurse for a family who has a child with special needs
 - **3 scholarships** for a week of before or after school care for a child whose family is in financial need
 - **over-the-counter medications** not covered by food stamp benefits for 10 families

- \$5** Per week provides:
- **breakfast & lunch** once a week for a year for 1 low income senior
 - annual **physicals & immunizations** for 2 adults and 2 children
 - **teeth cleanings** for 60 patients, preventing tooth decay and possible tooth loss

- \$7** Per week provides:
- **fall risk screenings and education** for 45 seniors reducing the risk of potential injury
 - **developmental toys** for infants and toddlers used during parenting lessons, promoting age-appropriate growth and development
 - one **full oil tank** so a local family can keep warm during winter

- \$10** Per week provides:
- **legal support** to ensure a laid off worker gets the Unemployment Compensation s/he is entitled to
 - subsidized **transportation costs** for a family allowing them to keep working and contributing to their family's stability
 - an **adaptive walker** for a child with Cerebral Palsy

- \$15** Per week provides:
- **dental fillings** for 4 children, eliminating pain of untreated cavities and preventing further disease
 - **grocery store gift cards** for 15 families so parents can feed their families
 - 10 **education advocacy trainings** for parents/caregivers to ensure that children get the school support they need to succeed

- \$20** Per week provides:
- a **month of fresh milk** for over 100 children at a child care center
 - help for two families to **avoid eviction** through back rent assistance and long term budget counseling
 - **legal assistance** and Protection From Abuse orders for 5 victims of domestic violence

- \$25** Per week provides:
- 3 months of **nutritious afternoon snacks** for 100 children in child care
 - **blood pressure screenings** for over 200 at-risk adults
 - **annual health and cancer screenings** for 20 uninsured low-income women

- \$50** Per week provides:
- **full prenatal workups** including ultrasound and lab work for two low-income uninsured women
 - two-hour **financial coaching appointments** for 50 at-risk families
 - **back to school clothes, shoes, supplies and a backpack** for 20 children who would otherwise not have what they need to be ready to learn
