Asset Limited. Income Constrained. Employed

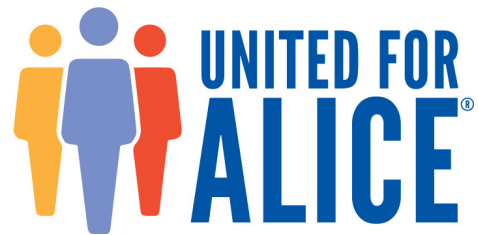
- **ALICE** has income above the FEDERAL poverty line, which makes ALICE ineligible for state and federal programs
