PROGRAM REQUIREMENTS

The course meets in regularly scheduled, full weekday sessions from October to May.

Participant Requirements include:

- Regular (75% or better) and attentive presence at sessions
- Demonstration of 75% proficiency in course learning objectives
- Active engagement in group project work, including out-of-session research and team meetings
- · Access to an internet-enabled computer or device
- Compliance with other participant guidelines

CURRICULUM

Session topics focus on:

- Best practices in nonprofit governance
- Awareness of Chester County's socio-economic landscape and community needs
- Developing open-minded, inclusive leaders

TUITION & FEES

Non-refundable tuition of \$2,500 is due upon acceptance. All participants must pay or be sponsored for their tuition fee.

A limited number of partial scholarships are competitively available. See "Application Requirements" below for information to include for scholarship consideration.

There is no application fee.

APPLICATION GUIDELINES

Application Requirements:

- Reservations and applications may be submitted throughout the year but should be received by September 30th.
- Resume must accompany completed application.
- Applicants requesting partial scholarships should submit with their completed applications
 - Case statement for individual financial need
 - o Letter from employer supporting participation and selection guidelines below
- Acceptance letters and invoices will be sent out following the application review process.

Selection Criteria

- Selection is based upon information in the application and supplemental documents. Interviews may be requested. The following will be evaluated in selecting participants:
 - Resourcefulness and innovation
 - Inclusive attitude
 - Demonstrated commitment to life-long learning and community involvement

- Evidence of effective interpersonal skills
- Good citizenship
- Recognition of the value of service leadership
